






A national forum of over 150 conservationists, including representatives of most of Australia's environment groups in Batemans Bay on 11th September, unanimously passed the following resolution:

FOREST FORUM BATEMANS BAY - 11 SEPTEMBER 2010

This meeting calls upon the Nippon Paper Group, as the second largest player after Gunns Limited in Australia's native forest wood chipping industry and owner of the Eden woodchip and the Maryvale paper mills to follow the lead of Gunns in acknowledging public opinion and announcing its exit from Australia's native forests and sourcing all its future woodchips from sustainably managed plantations.

We believe the time is overdue for Nippon to acknowledge, as most other Japanese paper manufacturers and Gunns have now done, that native forests are more valuable as carbon sinks, wildlife habitat and for regulating


